Review and certify nomination signatures for the remainder of the 3-year term for the elected third member's seat on the retirement board.

Executive Director Kristine Mathis began the meeting by informing the Council that staff had verified that nomination papers from Paula Light, Carolyn Manley, and Diana (Schindler) Parsons met the minimum requirement of 5 signatures from active, or retired Franklin Regional Retirement System members. The term will be from February 1, 2025, through December 31, 2026.

Susan Bobe made a motion to certify the nomination papers from Paula Light, Carolyn Manley and Diana (Schindler) Parsons and approve them as candidates for the position of Third Member Seat. Paula Harrison seconded the motion.

Review and approve the sample ballot.

A sample ballot was presented for approval (Attachment A.)

A motion was made by Jessalyn Zykoski to approve the sample ballot. Jan Warner seconded the motion.

Upon further discussion, Susan Bobe brought it to the council's attention that there was a formatting error to correct. Paula Harrison also made a suggestion to add the word "Third" to the ballot position title for clarity.

Jessalyn Zykoski made an amendment to approve the sample ballot with suggested changes. Jan Warner seconded the amended motion.

At this time, Susan Bobe inquired if one of the candidates was related to one of the staff members. And if so, if that warrants a conflict of interest.

Candidate Carolyn Manley explained she contacted the Ethics Committee and received a written approval letter stating the position of the Third Board Member has no direct oversight of Board staff, so she could fill the open seat if elected. It also stated she may need to recuse herself from some topics. Carolyn will share the letter with the Board if she is elected.

Select election date.

After some discussion concerning concerns of inclement weather, and the need to allow a couple of days to receive mail posted on January 23, 2025, which is the 20-day due date to have the ballots postmarked and returned after a January 3, 2025 mailing date of the ballots—A motion was made by Paula Harrison to make the election date Monday, January 27, 2025 at 1 PM. The motion was seconded by Jessalyn Zaykoski.
