General Business

1. Fourth Board Member Election Update

Congratulations were expressed as Incumbent Gabriele Voelker was the only candidate who submitted nomination papers for the 4th Board Member Seat. The nomination papers will be presented at the Advisory Council meeting on November 5, 2025, for certification.

2. Salary Survey Results

At the September Board meeting, a suggestion was made to look into other Western Massachusetts systems to get a retirement system wage survey. Also, a suggestion was made by Paula Light to look into how a COLA and Longevity Chart would work in lieu of a COLA and merit raise. Salary results were made available to the Board from several other retirement boards. Also, a spreadsheet calculating projected longevity payments, to possibly be implemented, was presented by Executive Director Kristine Mathis and Assistant Director Ashley Manley for FY 2027, if the Board decides to change the current COLA and merit rate salary increases to the longevity payments system. After discussion, Gabriele Voelker made a motion that we keep what we voted on the FY2026 Budget that includes a maximum of a 3.5% merit increase and that we look at changing our system for FY2027. Angel Bragdon seconded the motion. All ayes

3. Buyback/Makeup Policy Update

We received a denial letter again from PERAC regarding our updated Buyback/Makeup Policy. There is only one section that they are requesting that we update:

Any non-membership creditable service, including service credited as per M.G.L. 32 §4(2)(b), will be categorized with group 1 service when calculating a retirement allowance consisting of prorated benefits as prescribed by M.G.L. 32 §5(2)(a).

As per Board Legal Counsel Attorney Michael Sacco, the following changes were made:

Any non-membership creditable service awarded, with the exception of service purchased pursuant to M.G.L. 32, §4(2)(b) which was rendered as a reserve or permanent-intermittent police officer or a reserve, permanent-intermittent or call fire fighter, shall be categorized as Group 1 service. Creditable service awarded for service rendered as a reserve or permanent-intermittent police officer or a reserve, permanent-intermittent or call fire fighter, shall be considered Group 4 service. The Board will also classify any military service purchased or awarded pursuant to M.G.L. c. 32, § 4(1)(h) in the same group classification the member held at the time of the purchase, or if on a leave to serve in the miliary, in the same group when said leave was granted.

A motion was made by Paul Mokrzecki to amend our buyback policy, as recommended by PERAC, with the adjustments. Angel Bragdon seconded the motion. All ayes
